

Controls on Exports of Green List Waste to non-OECD Countries – an Update.

The current regulation (1418/2007/EC) providing control measures for the export of green list waste came into force on 29 November 2007. This regulation was amended in July 2008 by the regulation EC 740/2008.

Responses have been received for Algeria, Andorra, Argentina, Bangladesh, Belarus, Botswana, Bosnia and Herzegovina¹, Brazil, Chile, China, Chinese Taipei, Costa Rica, Croatia, Cuba, Egypt, Georgia, Guyana, Hong Kong, India, Indonesia, Iran¹, Israel, Ivory Coast (Cote d'Ivoire)¹, Kenya, Kyrgyzstan, Lebanon, Macau, Malawi, Mali, Malaysia¹, Moldova¹, Morocco, Oman, Pakistan, Paraguay, Peru, Philippines, Russian Federation¹, Seychelles, South Africa, Sri Lanka, Thailand, Togo¹, Tunisia, Ukraine¹ and Vietnam.

To assist exporters of green list waste, we have produced a summary table setting out the controls required for the export of key waste streams to the main export destinations. The table also highlights changes in the type of control specified.

Where a response has not been received from a country of destination notification controls will apply.
